ORDINANCE NO. 03-03-01-90

AN ORDINANCE AMENDING SECITON 41.07 PARKING PROHIBITED, OF CHAPTER 41, TRAFFIC OF THE MUNICIPAL CODE OF THE CITY OF LE ROY, ILLINOIS 1975 (as amended)

WHEREAS, the City of Le Roy, by ordinance, may provide for the prohibition of parking along city streets and ways,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled, as follows:

Section 1. Section 41.07 Parking Prohibited, of Chapter 41, Traffic, of the Municipal code of the City of Le Roy, Illinois, 1975 (as amended), is hereby amended by designating on Schedule A (a copy of which is attached hereto, labeled "Schedule A," and incorporated herein by reference) those additional "no parking" zones as indicated on the attached copy of the Schedule A (set forth in Exhibit I) in bold print. Any areas represented by a strikeout through the language will be considered deleted. All other zones shown in small print are existing "no parking" zones, as currently shown on Schedule A prior to the adoption of this ordinance.

Section 2. The attached copy of the aforesaid Schedule A (a second copy of Schedule A, shown as Exhibit I to this ordinance) is hereby approved as being the most current copy of said schedule and all no parking zones as stated therein are hereby approved and ordained as being in full force and effect as of this date.

Section 3. Signs shall immediately be erected for the purpose of regulating the aforesaid "No Parking Zone" zones as previously described in this ordinance. Upon the erection of the aforesaid signs and the completion of publication of this ordinance, the city police department shall begin enforcement of the regulations as set forth in this ordinance.

<u>Section 4.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.

SCHEDULE A

- In accordance with Section 41.07 the following places are designated as NO PARKING ZONES FROM 11:00 PM EACH DAY UNTIL 6:00 AM THE SUCCEEDING DAY:
 - a. Both sides of each street bordering the Le Roy Park District Swimming Pool including both sides of Washington Street in the portion of that street located between the East right-of-way line of Pearl Street and the West right-of-way line of East Street; both sides of Pearl Street in the portion of that street located between the North right-of-way line of Washington Street and the South right-of-way line of Warren Street; both sides of Warren Street in the portion of that street located between the East right-of-way line of Pearl Street and the West right-of-way of East Street; and both sides of East Street in the portion of that street located between the South right-of-way line of Warren Street and the North right-of-way line of Washington Street;
 - b. All parts of Main Street and Center Street around the city park located in the circle at the intersections of Center Street and Main Street, including the Northerly, Easterly, Southerly and Westerly bounds of the paved portions of said streets around the aforesaid park.
- 2. In accordance with Section 41.07, the following places are designated as NO PARKING ZONES AT ALL TIMES:
 - a. North and South sides of Center Street from the West side of Buck Street to the East side of West Street, all in the City of Le Roy, McLean County, Illinois.
 - b. U.S. Route 150, both sides, from the West city limits to the East city limits.
 - c. North and South sides of East Maple Street from the East side of East Street to the entrance to the City of Le Roy Sewage Treatment Plant.
 - d. Easterly and westerly, and northerly and southerly sides of South Hemlock Street, from the intersection of said street with the southerly and westerly right-of-way boundary of Interstate Route 74 with the easterly and westerly right-of-way lines of Hemlock Street, southerly and then easterly to the intersection of the southern extension of Hemlock Street with Chestnut Street after the same crosses over I-74 and connects with the Route 136 spur road, south from the I-74 / Chestnut Street overpass in the City of Le Roy.
 - e. All of Maple Street west of the northerly and westerly right-of-way line of South Chestnut Street and Sunset Drive from the west boundary line of Golden Centre Subdivision east to Maple Street.
 - f. NO PARKING THIS SIDE

North Chestnut

between Oak & Elm,

(east side of street)

between North and Washington, between Washington and Warren, between Warren and Green, between Green and Wayne,

between Wayne and School.

North Lynn Street (west side of street)

between East Cherry & East Center

South Mill Street

between south right-of-way line of East Center Street, and the north right-of-way

line of East Pine Street

North Barnett Street

the first ninty feet of the east side of North

Barnett beginning at the curb of North

Barnett and East Center Street

3. In accordance with Section 41.07, the following places are designated as NO PARKING ZONES AT ALL TIMES OTHER THAN AS SET FORTH HEREINAFTER:

East side of South Mill Street, south of the south right-of-way line of East Center Street and north of the north right-of-way line of East Pine Street;

The aforesaid "No Parking" zone shall be no parking at all times, except for persons attending school during school hours, persons attending school events, and persons attending community events.
