AN ORDINANCE PROVIDING FOR THE RESTRICTION OF PARKING ALONG U.S. ROUTE 150 THROUGH THE CITY OF LEROY FROM THE WEST CITY LIMITS TO THE EAST CITY LIMITS

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, find that it is in the best interests of the residents of the City of LeRoy and of the public in general, that the City provide for the restriction of parking along U.S. Route 150 through the City of LeRoy, from the west city limits to the east city limits,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

Section 1. In order to provide for the health, safety and welfare of its citizens, parking is prohibited on both sides of U.S. Route 150, extending from the west corporate limits of the City of LeRoy easterly and southerly 1.56 miles to the east corporate limits of the City of LeRoy, which previously described distance along U.S. Route 150 includes those portions of Washington, Walnut, and Cedar Streets in the City of LeRoy, designated and marked U.S. Route 150.

Section 2. Any person, firm, or corporation violating the provisions of this ordinance shall be fined not less than \$50.00 nor more than \$500.00 for each offense.

Section 3. The City of LeRoy shall enact further ordinances regarding parking restrictions at locations immediately adjacent to the improvement, as may be determined to be necessary by the State of Illinois from results of traffic capacity studies when construction on the above-described State of Illinois section of U.S. Route 150 has been completed and the affected highway resumes normal operations.

<u>Section 4.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
