ORDINANCE NO. 822

AN ORDINANCE AMENDING SECTION 41.07 PARKING PROHIBITED, OF CHAPTER 41, TRAFFIC OF THE MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS 1975 (as amended)

WHEREAS, the Mayor and City Council of the city of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that the area hereinafter described, located within the City of LeRoy, Illinois, is appropriate to be declared a "No Parking" zone, other than as hereinafter provided, due to its location and the adjacent area; and

WHEREAS, the City of LeRoy, by ordinance, may provide for the prohibition of parking along city streets and ways;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. Section 41.07 Parking Prohibited, of Chapter 41, Traffic, of the Municipal code of the City of LeRoy, Illinois, 1975 (as amended), is hereby amended by designating on Schedule A (a copy of which is attached hereto, labeled "Schedule A," and incorporated herein by reference) those additional "no parking" zones as indicated on the attached copy of the Schedule A (set forth in Exhibit I) in bold print. All other zones shown in smaller print are existing "no parking" zones, as currently shown on Schedule A prior to the adoption of this ordinance.

- Section 2. The attached copy of the aforesaid Schedule A (a second copy of Schedule A, shown as Exhibit I to this ordinance) is hereby approved as being the most current copy of said schedule and all no parking zones as stated therein are hereby approved and ordained as being in full force and effect as of this date.
- <u>Section 3</u>. Signs shall immediately be erected for the purpose of regulating the aforesaid "No Parking Zone" zones as previously described in this ordinance. Upon the erection of the aforesaid signs and the completion of publication of this ordinance, the city police department shall be gin enforcement of the regulations as set forth in this ordinance.
- <u>Section 4</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.

SCHEDULE A

- 1. In accordance with Section 41.07 the following places are designated as NO PARKING ZONES FROM 11:00 P.M. EACH DAY UNTIL 6:00 A.M. THE SUCCEEDING DAY:
 - a. South Mill Street, and the portion of LeRoy Schools' parking lot located on and along said part of Mill Street, in the Block between the South right of way line of East Center Street and the North right of way line of East Pine Street:
 - b. Both sides of each street bordering the LeRoy Park District Swimming Pool including both sides of Washington Street in the portion of that street located between the East right-of-way line of Pearl Street and the West right-of-way line of East Street; both sides of Pearl Street in the portion of that street located between the North right-of-way line of Washington Street and the South right-of-way line of Warren Street in the portion of that street located between the East right-of-way line of Pearl Street and the West right-of-way line of East Street; and both sides of East Street in the portion of that street located between the South right-of-way line of Warren Street and the North right-of-way line of Washington Street;
 - c. All parts of Main Street and Center Street around the city park located in the circle at the intersections of Center Street and Main Street, including the Northerly, Easterly, Southerly, and Westerly bounds of the paved portions of said streets around the aforesaid park.
- 2. In accordance with Section 41.07, the following places are designated as NO PARKING ZONES AT ALL TIMES:
 - a. North and South sides of Center Street from the West side of Buck Street to the East side of West Street, all in the City of LeRoy, McLean County, Illinois.
 - b. U.S. Route 150, both sides, from the West city limits to the East city limits.
 - c. North and South sides of East Maple Street from the East side of East Street to the entrance to the City of LeRoy Sewer Treatment Plant.
 - d. Easterly and westerly, and northerly and southerly sides of South Hemlock Street, from the intersection of said street with the southerly and westerly right-of-way boundary of Interstate Route 74 with the easterly and westerly right-of-way lines of Hemlock Street, southerly and then easterly to the intersection of the southern extension of Hemlock Street with Chestnut Street after the same crosses over I-74 and connects with the Route 136 spur road, south from the I-74 / Chestnut Street overpass in the City of LeRoy.

e. All of Maple Street west of the northerly and westerly right-of-way line of South Chestnut Street and Sunset Drive from the west boundary line of Golden Centre Subdivision east to Maple Street.

f. NO PARKING THIS SIDE

North Chestnut (east side of street)

between Oak & Elm,

North and Washington,Washington and Warren,

Warren and Green,Green and Wayne,

" Wayne and School.

North Lynn Street (west side of street)

between East Cherry Street & East Center Street

South Mill Street (west side of street)

- 3. In accordance with Section 41.07, the following places are designated as NO PARKING ZONES AT ALL TIMES OTHER THAN AS SET FORTH HEREINAFTER:
 - a. South side of East Center Street between Lynn Street and Mill Street, said area being specifically described as follows:

Beginning at a point 140 feet west from the west side of the west curb on South Lynn Street, west to a point 205 feet west of the west side of the west curb on South Lynn Street, the area between the two designated points being 65 feet in length and being the "No Parking" zone;

The aforesaid "No Parking" zone is reserved for emergency vehicles only when responding to a call for emergency response at the LeRoy High School or vicinity. Signage shall be erected by the street department indicating, as appropriate, the zone is reserved for emergency vehicles only, responding to calls for emergency assistance, and is a "No Parking" zone as to all other vehicles at all times.

b. East side of South Mill Street, south of hie south right-of-way line of East Center Street and north of the north right-of-way line of East Pine Street;

the aforesaid "No Parking" zone shall be no parking at all times, except for persons attending school or school during school hours, persons attending school events, and persons attending community events.

SCHEDULE A

- 1. In accordance with Section 41.07 the following places are designated as NO PARKING ZONES FROM 11:00 P.M. EACH DAY UNTIL 6:00 A.M. the succeeding day:
 - a. South Mill Street, and the portion of LeRoy Schools' parking lot located on and along said part of Mill Street, in the Block between the South right of way line of East Center Street and the North right of way line of East Pine Street:
 - a. Both sides of each street bordering the LeRoy Park District Swimming Pool including both sides of Washington Street in the portion of that street located between the East right-of-way line of Pearl Street and the West right-of-way line of East Street; both sides of Pearl Street in the portion of that street located between the North right-of-way line of Washington Street and the South right-of-way line of Warren Street in the portion of that street located between the East right-of-way line of Pearl Street and the West right-of-way line of East Street; and both sides of East Street in the portion of that street located between the South right-of-way line of Warren Street and the North right-of-way line of Washington Street;
 - b. All parts of Main Street and Center Street around the city park located in the circle at the intersections of Center Street and Main Street, including the Northerly, Easterly, Southerly, and Westerly bounds of the paved portions of said streets around the aforesaid park.
- 2. In accordance with Section 41.07, the following places are designated as NO PARKING ZONES AT ALL TIMES:
 - a. North and South sides of Center Street from the West side of Buck Street to the East side of West Street, all in the City of LeRoy, McLean County, Illinois.
 - b. U.S. Route 150, both sides, from the West city limits to the East city limits.
 - c. North and South sides of East Maple Street from the East side of East Street to the entrance to the City of LeRoy Sewer Treatment Plant.
 - d. Easterly and westerly, and northerly and southerly sides of South Hemlock Street, from the intersection of said street with the southerly and westerly right-of-way boundary of Interstate Route 74 with the easterly and westerly right-of-way lines of Hemlock Street, southerly and then easterly to the intersection of the southern extension of Hemlock Street with Chestnut Street after the same crosses over I-74 and connects with the Route 136 spur road, south from the I-74 / Chestnut Street overpass in the City of LeRoy.

e. All of Maple Street west of the northerly and westerly right-of-way line of South Chestnut Street and Sunset Drive from the west boundary line of Golden Centre Subdivision east to Maple Street.

f. NO PARKING THIS SIDE

between Oak & Elm,

North and Washington,Washington and Warren.

" Warren and Green,

" Green and Wayne," Wayne and School.

North Lynn Street (west side of street)

between East Cherry Street & East Center Street

South Mill Street (west side of street)

3. In accordance with Section 41.07, the following places are designated as no parking zones at all times other than as set forth hereinafter:

South side of East Center Street between Lynn Street and Mill Street, said area being specifically described as follows:

Beginning at a point 140 feet west from the west side of the west curb on South Lynn Street, west to a point 205 feet west of the west side of the west curb on South Lynn Street, the area between the two designated points being 65 feet in length and being the "No Parking" zone;

The aforesaid "No Parking" zone is reserved for emergency vehicles only when responding to a call for emergency response at the LeRoy High School or vicinity. Signage shall be erected by the street department indicating, as appropriate, the zone is reserved for emergency vehicles only, responding to calls for emergency assistance, and is a "No Parking" zone as to all other vehicles at all times.
