ORDINANCE NO. 823

AN ORDINANCE AMENDING ORDINANCE NO. 516 ESTABLISHING THRU TRUCK ROUTES AND LMITING TRUCK TRAFFIC ON ALL OTHER STREETS AND WAYS IN THE CITY OF LEROY, CHAPTER 41 OF THE MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (as amended).

WHEREAS, the City of Leroy, McLean County, Illinois, an Illinois municipal corporation, adopted Ordinance No. 516 on October 18, 1993, establishing thru truck routes in the city and limiting truck traffic on all other streets and ways in the City of LeRoy; and

WHEREAS, the Mayor and City Council of the City of LeRoy have determined that it is in the best interests of the City of LeRoy and its citizens, and for their safety and welfare, that the aforesaid ordinance be amended,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. New Section 41.20, sub-section (a.5) of Chapter 41-Traffic of the Municipal Code of the City of LeRoy, 1975 (as amended), is hereby adopted in words and figures as follow:

141.20 (a.5) It shall be unalwful to operate a commercial vehicle as "commercial vehicle" is defined under Section 41.20 of Chaper 41, Traffic, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), upon Maple Street west of the northerly and westerly right-of-way line of South Chestnut Street and Sunset Drive from the west boundary line of Golden Centre Subdivision east to Maple Street. Signs shall be posted at the intersection of South Chestnut Street and Maple Street indicating the prohibition of travel of commercial vehicles upon said Maple Street and Sunset Drive. However, commercial vehiclals may be driven on such streetsfor not more than the minimum distance necessary for the purpose of making deliveries, picking up loads, performing contractual services for hire, or pick up of personal property.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
