# AN ORDINANCE AMENDING TITLE SIX – MOTOR VEHICLES AND TRAFFIC; CHAPTER TWO – TRAFFIC REGULATIONS; SECTION FIVE TRAFFIC REGULATIONS ON SPECIFIC STREETS OF THE MUNICIPAL CODE OF THE CITY OF LE ROY, 2003 (AS AMENDED)

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have determined that the intersections hereinafter described, located within the City of Le Roy, Illinois, are appropriate to be controlled by stop and yield signs at said intersections; and

WHEREAS, the City of Le Roy, by ordinance, may provide for the erection of stop and yield signs to control a street intersection

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled, as follows:

Section 1. Motor Vehicles and Traffic Regulations, Traffic Regulations on Specific Streets of the Municipal Code of the City of Le Roy, Illinois, 2003(as amended), is hereby amended in words and figures as follows:

on South East Street and eastbound on Sunset Street
