## **ORDINANCE NO. 12-08-04-90**

# AN ORDINANCE AMENDING TITLE SIX – MOTOR VEHICLES AND TRAFFIC; CHAPTER TWO – TRAFFIC REGULATIONS; SECTION FIVE TRAFFIC REGULATIONS ON SPECIFIC STREETS OF THE MUNICIPAL CODE OF THE CITY OF LE ROY, 2003 (AS AMENDED)

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have determined that the intersections hereinafter described, located within the City of Le Roy, Illinois, are appropriate to be controlled by stop and yield signs at said intersections; and

WHEREAS, the City of Le Roy, by ordinance, may provide for the erection of stop and yield signs to control a street intersection

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled, as follows:

Section 1. Motor Vehicles and Traffic, Traffic Regulations, Traffic Regulations on Specific Streets of the Municipal Code of the City of Le Roy, Illinois, 2003(as amended), is hereby amended in words and figures as follows:

Section 2. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.

## SCHEDULE E

### **STOP SIGNS**

### TWO - WAY STOPS

- 1. North Pearl Street and East Elm Street Stop signs to be located are eastbound/westbound on East Elm Street.
- 2. North East Street and East Elm Street Stop signs to be located are eastbound/westbound on East Elm Street.
- 3. North Chestnut Street and East Elm Street Stop signs to be located are eastbound/westbound on East Elm Street.
