BE IT ENACTED by the CITY COUNCIL OF THE CITY OF LE ROY, at the regular meeting held on the 6th day of March , 1986, that the following traffic regulations, stop signs, speed zones and location of traffic signs are hereby established for the CITY OF LE ROY, in addition to any other existing Ordinances dealing with the same subject:

8 STOP SIGNS: 1 to be installed on Barnett Street at Washington Street for northbound traffic 1 to be installed on Washington Street at Barnett Street for east bound traffic 1 to be installed on Washington Street at Barnett Street for west bound traffic 1 to be installed on Mill Street at Washington Street for south bound traffic 1 to be installed on Washington Street at Mill Street for east bound traffic 1 to be installed on Washington Street at Mill Street for west bound traffic 1 to be installed on Chestnut Street at Washington Street for north bound traffic 1 to be installed on Chestnut Street at Washington Street for south bound traffic

Violations of any of the above regulations by any person shall be a violation of law and shall subject such violator to the penalties described in the City Code for the City of Le Roy, Illinois, Chapter 41.
