## ORDINANCE NO. 282

BE IT ENACTED by the CITY COUNCIL OF THE CITY OF LE ROY, at the regular meeting held on the <u>4th</u> day of <u>August</u>, 19 86, that the following traffic regulations, stop signs, speed zones and location of traffic signs are hereby established for the CITY OF LE ROY, in addition to any other existing Ordinances dealing with the same subject:

l to be installed on Oak Street at West Street for eastbound traffic l to be installed on Oak Street at West Street for westbound traffic l to be installed on Pearl Street at Washington Street for northbound traffic l to be installed on Pearl Street at Washington Street for southbound traffic l to be installed on Warren Street at East Street for eastbound traffic l to be installed on Warren Street at East Street for westbound traffic

Violations of any of the above regulations by any person shall be a violation of law and shall subject such violator to the penalties described in the City Code for the City of Le Roy, Illinois, Chapter 41.
