## ORDINANCE NO. 311

BE IT ENACTED by the CITY COUNCIL OF THE CITY OF LE ROY, at the regular meeting held on the 7th day of <u>December</u>, 1987, that the following traffic regulations, stop signs, speed zones and location of traffic signs are hereby established for the CITY OF LE ROY, in addition to any other existing Ordinances dealing with the same subject:

3 STOP SIGNS: 1 to be installed on Barnett Street at Cherry Street for northbound traffic

1 to be installed on Cherry Street at Barnett Street for eastbound traffic 1 to be installed on Cherry Street at Barnett Street for westbound traffic

Violations of any of the above regulations by any person shall be a violation of law and shall subject such violator to the penalties described in the City Code for the City of Le Roy, Illinois, Chapter 41.
