- l yield sign on Oak Street at Barnett Street
- l yield sign on Oak Street at Mill Street
- 1 one-way sign on Oak Street at Barnett Street
- 1 one-way sign on Oak Street at Mill Street

Violations of any of the above regulations by any person shall be a violation of law and shall subject such violator to the penalties described in the City Code for the City of Le Roy, Illinois, Chapter 41.
