ORDINANCE NO. 401

AN ORDINANCE CHANGING THE NAME OF A PRIVATE CITY ROADWAY

WHEREAS, the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, has a private roadway extending from South East Street, easterly to the sewer treatment plant facility entrance, and

WHEREAS, the Mayor and City Council of the City of LeRoy deem it appropriate to rename that private road, said roadway being presently referred to as "Sewer Plant Access Road" and, occasionally, "Sewer Plant Road,"

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. That the name of the sewage treatment plant facility entrance road is hereby changed from "Sewer Plant Road" (also sometimes known as "Sewer Plant Access Road") to "EAST MAPLE STREET."

Section 2. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
