ORDINANCE NO. 00-02-01-51

AN ORDINANCE APPROVING FINAL SUBDIVISION PLAT FOR PLEASANT VALLEY SUBDIVISION SECOND ADDITION TO THE CITY OF LEROY, ILLINOIS

Upon recording the same the developer shall provide copies of said recorded plat as may be appropriate to the City for record purposes.


<u>Section 3.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
