#### ORDINANCE NO. 11-07-01-52

### AN ORDINANCE APPROVING THE FINAL PLAT OF THE FIRST ADDITION TO WATER TOWER PLAZA SUBDIVISION, TO THE CITY OF LE ROY, MCLEAN COUNTY, ILLINOIS

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have reviewed the proposed final plat of the Water Tower Subdivision; and

WHEREAS, the Mayor and City Council of the City of Le Roy have determined that said final plat is valid and sufficient and conforms to the requirements of the statutes in such cases and in compliance with the subdivision code of the City of Le Roy, and that the approval of said proposed final plat is in the best interests of the city and its residents;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, McLean County, Illinois, in lawful meeting assembled, as follows:

<u>Section 1:</u> The final plat of **Water Tower Plaza Subdivision** to the City of Le Roy, McLean County, Illinois, a copy of which is attached hereto as Exhibit A, and incorporated herein by reference, is hereby approved, subject to those conditions as set forth hereinafter.

Section 2: This ordinance shall be in full force and effect from and after its passage, approval and publication, as required by law.

#### PARCEL 1:
