ORDINANCE NO. 568

AN ORDINANCE APPROVING THE FINAL PLAT OF FIRST ADDITION TO SPRINGCREST ESTATES SUBDIVISION

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have heretofore informally approved the Final Plan and Final Plat of FIRST ADDITION TO SPRINGCREST ESTATES SUBDIVISION, which plan and plat meet all requirements of the Subdivision Code of the City of LeRoy; and

WHEREAS, there has been submitted to the City of LeRoy a final plat of FIRST ADDITION TO SPRINGCREST ESTATES SUBDIVISION (Exhibit A, attached hereto and incorporated herein by reference) which in all respects substantially conforms to the plan approved by the Mayor and City Council, and all other requirements of the Subdivision Code of the City of LeRoy having been met,

- <u>Section 2.</u> Any requirement to post any type of bond, as may otherwise be required in accordance with the current subdivision code of the City of LeRoy, is hereby waived.
- Section 3. The final plat of FIRST ADDITION TO SPRINGCREST ESTATES SUBDIVISION, as shown in Exhibit A (attached hereto), incorporated herein by reference, is hereby approved.
- <u>Section 4.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law
