ORDINANCE NO. 750

AN ORDINANCE PROVIDING FOR SUBORDINATION OF THE CITY OF LEROY'S LIEN RIGHTS IN CONNECTION WITH GOLDEN EAGLE SEWER CONSTRUCTION CONTRACTS AND LIENS OF SAME AGAINST REAL ESTATE

WHEREAS, the City of LeRoy has provided by written contract entered into with various lot owners in the Golden Eagle Estate Subdivision for the installment payment of a sewer construction fee; and

WHEREAS, said contracts were recorded as to each lot in the aforesaid subdivision, thus creating a lien against an owner's title to each of said lots; and

WHEREAS, from time to time bank lenders lending funds to lot owners for purchase of a lot, a lot with a home on it, or for improvements to homes and lots, or for home equity loans, may require subordination of the City's lien rights and interest in a lien against the title to such lot(s) before the bank lender will move forward with the loan and close the same; and

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, find it is in the best interests of the city and its residents to provide the Mayor of the City of LeRoy with authority to agree to subordinate the City's interest in the aforesaid contract rights from time to time upon request by lot owners or prospective purchasers,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled as follows:

Section 1: That subordination agreement, a copy of which is attached hereto, labeled Exhibit A, incorporated herein by reference, between Citizens Savings Bank and the City of LeRoy, is hereby approved. Further the mayor and city clerk are hereby directed to sign two copies of that subordination agreement prepared by Citizens Savings Bank in regard to a loan proposed to be made to Scott Riddle and Staci Riddle. One signed copy shall be kept with the records of the City of LeRoy and the second signed copy shall be forwarded to Citizens Savings Bank.

Section 2: In the future, any request for a subordination agreement made to the City of LeRoy requesting subordination of the City's lien rights and priority collateral interests in a sewer

construction fee contract for any lot in the Golden Eagle Estate Subdivision may be approved by the mayor and signed by the Mayor of the City of LeRoy without further approval by the city council. The mayor shall report, in writing, to the city council any time such a subordination agreement is approved and signed by the mayor, and the city clerk shall keep a record as to each lot in the Golden Eagle Subdivision regarding those lots for which contracts for installment payments of the sewer construction fee have been entered into with the lot owners, and as to such lots, those that have a subordination agreement approved from time to time by the City of LeRoy, acting either through the city council, or through the mayor.

Section 3: This ordinance shall be in full force and effect from and after its approval and publication in pamphlet form as required by law.
