AN ORDINANCE GRANTING A VARIANCE OF THE REQUIREMENTS OF THE SUBDIVISION CODE OF THE CITY OF LEROY, MC LEAN COUNTY, ILLINOIS, AS PROVIDED UNDER SECTION 22.10 OF CHAPTER 22 SUBDIVISIONS, MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS, 1975 (AS AMENDED)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, have determined that a proposed subdivision of Lots 7,8 and 9 in Block 139 of Wood and Conkling's Addition to the City of LeRoy is appropriate; and

WHEREAS, Section 22.10 Subdivision of Small Tracts, of Chapter 22 SUBDIVISIONS, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), provides for a certain expediting of subdivision approval procedures and a method by which relief can be granted in unique and unusual situations concerning small tracts of land,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

<u>Section 1</u>. The request by Joan Cook, owner of Lots 7, 8 and 9 in Block 139 of Conkling's Addition to the City of LeRoy, McLean County, Illinois, to subdivide said lots in to the following two tracts, described as follows:

Tract 1: Lot 7, EXCEPT the North 20 feet thereof and Lot 8, EXCEPT the North 20 feet and the East 10.37 feet thereof, all in Block 139 of Wood & Conkling's Addition to the City of LeRoy, McLean County, Illinois.

<u>Tract 2</u>: The North 20 feet of Lot 7, the North 20 feet and the East 10.37 feet of Lot 8 and all of Lot 9, all in Block 139 of Wood & Conkling's Addition to the City of LeRoy, McLean County, Illinois.

is hereby approved. Further, in accordance of Section 22.10 of Chapter 22 SUBDIVISIONS, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), the City Council hereby finds that the plat of resubdivision of the aforesaid Lots 7,8 and 9 is a plat of resubdivision of a small tract of land. After consideration of said request, the City Council is of the opinion that the intent and purpose of the provisions of Chapter 22 SUBDIVISIONS of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended) are not violated by such plat and that construction of the improvements required in accordance with Chapter 22 of the aforesaid municipal code are not applicable, at least in certain instances, or cannot be reasonably enforced. Therefore, the City

Council hereby waives the application or enforcement of the provisions of Chapter 22 SUBDIVISIONS of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended) and hereby approves the aforesaid plat, a copy of which is attached hereto as Exhibit A and incorporated herein by reference, without requiring the applicant, Joan Cook, to proceed further in accordance with Chapter 22 SUBDIVISIONS of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended).

- <u>Section 2</u>. The City Council hereby finds that all the recitals contained in the preambles and recitals to this ordinance are true, complete and correct, and they hereby incorporate such preambles and recitals into this ordinance by this reference thereto.
- Section 3. All ordinances, or parts thereof, resolutions, or parts thereof, in conflict with this ordinance shall be and the same are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.
- Section 4. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or any liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost impaired or affected by this ordinance.
- <u>Section 5</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
