 $\,$ BE IT ORDAINED by the Mayor and the City Council of the City of LeRoy, Illinois:

Section 1. That Chapter 3, Section 3.05(a) is hereby amended by deleting the present language and heading and adding the following language to read:

"(a) How Let; Special Assessments; Exceeding \$2,500.00. All contracts for the making of any public improvement in the city which is not to be paid for in whole or in part by a special assessment or special taxation, and any other work or other public improvement, when the expense thereof shall exceed the sum of \$2,500.00, shall be let to the lowest responsible bidder therefor in the manner prescribed herein, and shall be approved by the Mayor."

Section 2. That Chapter 3, Section 3.05(b) is hereby amended by adding the word "not" before the words "to be paid for in whole or in part by special assessment" and is further amended by deleting the words "or otherwise," following the last quoted language and in place of said deleted words adding the language "or special taxation,".

Section 3. That Chapter 3, Section 3.05(c) is hereby amended by adding the word "not" before the words "to be paid for in whole or in part by special assessment or special taxation,", and deleting the words "as soon as the special tax or special assessment for such improvement shall have been finally confirmed, as provided by law," and by adding the words "with the advice and consent of the City Council" after the words "the Mayor".

 $\frac{\text{Section 4.}}{\text{and after}}$ This Ordinance shall be in full force and effect from $\frac{\text{and after}}{\text{and after}}$ its passage and approval, as required by law.
