## **ORDINANCE NO. 05-07-03-51**

# AN ORDINANCE APPROVING A TEXT AMENDMENT TO THE MUNICIPAL CODE, LE ROY, ILLINOIS, 2003 TITLE 10, ZONING

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, deem it to be in the best interests of the city and its residents that the zoning ordinance amendments hereinafter set forth be approved, and

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois, on July 7, 2005 at 7:00 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the Ordinance of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances, and

WHEREAS, said Zoning Board of Appeals did hold a hearing as required by the laws of the State of Illinois and the Ordinance of the Sity of Le Roy; McLean County, Illinois and did recommend that said petition for text amendment be passed, and

WHEREAS, all things required by law and ordinance to be done in regard to the amendment of the hereinafter described text have been completed,

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

**SECTION 1.** Title 10, Chapter 3, Section 9 (Permitted Obstructions): A new subsection (F) shall be created and worded as follows. Front Yards: Open, unenclosed ramps, decks, porches, platforms or landings, not covered by a roof, shall be permitted to extend no more than 6 feet (1829 mm) or 24% of the required front yard, whichever is less, into the required front yard, provided such porch does not extend above the first level and is no more than 6 feet (1829 mm) above grade at any point.

**SECTION 2.** Title 10, Chapter 6A, Section 4(B-3-a):

will be replaced with the new paragraph (a) as follows.

Front yards to be that distance from the front lot line to the front foundation of the house which would be the average distance of said dimension of all existing dwellings on that side of the block, said average distance to be determined by measuring a distance from the front foundation of each house to the front lot line of each lot, adding all said measurements together and dividing by the number of dwelling structures so measured, all said dwelling structures and measurements to be for those dwellings fronting on the same side of the block as the proposed structure (said measurements shall be from the foundation of each dwelling structure and shall not be made from a front porch, step or stoop(See 10-3-9-F)), in any event, the front yard to be not less than fifteen feet (15');

rear, twenty five feet (25'); side to be not less than ten percent (10%) of the lot width for each side yard, in any event, not less than five feet (5'); said front, rear and side yard setback requirements to be applicable only to those lots platted prior to December 13, 1973, and being less than seventy five feet (75') in width.

Title 10, Chapter 6B, Section 4(B-3-a):

will be replaced with the new paragraph (a) as follows.

Front yards to be that distance from the front lot line to the front foundation of the house which would be the average distance of said dimension of all existing dwellings on that side of the block, said average distance to be determined by measuring a distance from the front foundation of each house to the front lot line of each lot, adding all said measurements together and dividing by the number of dwelling structures so measured, all said dwelling structures and measurements to be for those dwellings fronting on the same side of the block as the proposed structure (said measurements shall be from the foundation of each dwelling structure and shall not be made from a front porch, step or stoop(See 10-3-9-F)), in any event, the front yard to be not less than fifteen feet (15'); rear, twenty five feet (25'); side to be not less than ten percent (10%) of the lot width for each side yard, in any event, not less than five feet (5'); said front, rear and side yard setback requirements to be applicable only to those lots platted prior to December 13, 1973, and being less than seventy five feet (75') in width.

**SECTION 3.** This ordinance shall be in full force and effect from and after its passage and approval as required by law.
