**AN ORDINANCE AMENDING THE AGRICULTURAL DISTRICT  
REGULATIONS IN THE ZONING REGULATIONS OF THE CITY CODE**

**WHEREAS**, the City of Le Roy is an Illinois non-home rule municipality organized and operating under the Illinois Municipal Code; and

**WHEREAS**, the City desires to amend the zoning regulations of the City Code to allow greenhouses as a permitted use in the A-Agricultural District; and

**WHEREAS**, in accordance with Section 10-2-7 of the City Code and pursuant to notice duly published, the Le Roy Zoning Board of Appeals conducted a public hearing on July 10, 2014, for the purpose of hearing and considering testimony on the proposed amendments to the zoning regulations; and

**WHEREAS**, at the conclusion of the public hearing, the Zoning Board of Appeals recommended approval of the proposed amendments to the zoning regulations.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Le Roy, McLean County, Illinois, as follows:

**Section 1. Recitals.** The Council hereby finds that all of the recitals contained in the preambles to this Ordinance are full, true and correct and does incorporate them into this Ordinance by this reference.

**Section 2. Amendment to Section 10-5-2.** Section 10-5-2, entitled "Permitted Uses" of Chapter 5, entitled "A Agricultural District," of the City of Le Roy Code of Ordinances is hereby amended to add "Greenhouses" as a permitted use in the Agricultural District, as follows:

**10-5-2: PERMITTED USES:**

The following uses are permitted in the A agricultural district:

Agricultural uses.

Parks and recreation areas.

Single-family residences accessory to agricultural operations.

**Greenhouses**

**Section 3. Conflict.** All Ordinances and parts of Ordinances in conflict with this Ordinance are hereby repealed.

**Section 4. Effective Date.** This Ordinance shall be in full force and effect following its passage and approval as required by law.
