AN ORDINANCE AMENDING THE MUNICIPAL CODE, LE ROY, ILLINOIS. 1975, CHAPTER 21, ZONING, SECTION 21.09 (e)3.

Whereas, the Mayor and City Council of the City of LeRoy, Illinois, an Illinois municipal corporation, have determined that there are a number of alleys and platted alley-ways within the City of LeRoy, which alleys and platted alley-ways are not commonly used for the passage of vehicular traffic, and which are not likely to be commonly used for such purposes in the future, and

Whereas, the Mayor and City Council of the City of LeRoy have determined that it is in the best interests of the city and its residents that the city retain these rights of way, both surface and sub-surface rights and uses, to the city for the future, and

Whereas, the Mayor and City Council of the City of LeRoy have determined that it would be of benefit to persons owning lots adjacent to any alley or platted alley-way within the city that such land owners be permitted to construct private garages or other accessory buildings or uses closer to the rear or side lot line adjacent to the aforesaid alley or platted alley ways than is now permitted by the rear and side yard requirements (set-back requirements) as provided in Chapter 21, Article 21.09, Section (e)3., Municipal Code of LeRoy, 1975 (as amended),

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembed, as follows:

Section 1. That Chapter 21, Section 21.09 (e)3. be further amended to read as follows:

" [21.09] (e)3. - b. Exception. A private garage or other accessory use or structure may be constructed adjacent to a rear or side lot line when such rear or side lot line is bordered by an alley or alley-way owned by the city, and the aforesaid rear yard and side yard requirements shall not be applicable as to such private garage or other accessory use, but only as to the side or sides of the lot adjacent to the alley or alley-way."

Section 2. This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by city ordinance and state law.
