AN ORDINANCE AMENDING CHAPTER 21 ZONING, SECTION 21.04 (19), "Drive-in Establishment", MUNICIPAL CODE OF LEROY, ILLINOIS 1975 (as amended).

Whereas, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that the definition of "drive-in establishment" set forth at Item 19, Section 21.04, Chapter 21 Zoning, of the Municipal Code of LeRoy, Illinois 1975 (as amended), is ambiguous or unduly restrictive, and

Whereas, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, have determined that amendment of the definition would be in the best interests of the City of LeRoy and of its residents,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled:

Section 1. That Section 21.04 (19) of Chapter 21 Zoning, Municipal Code of LeRoy, Illinois 1975 (as amended), is hereby repealed.

Section 2. That new Section 21.04 (19) of Chapter 21 Zoning. Municipal Code of LeRoy, Illinois 1975 (as amended), in the words as follows is hereby adopted:

> "Drive-in Establishment. A business or institution where a principal use is the offering or sale of goods or services to be carried out to, or to be served to, customers waiting in parked motor vehicles, or a prepared food or beverage carry-out service. Such establishment may also have facilities for offering or selling goods or services to customers for use or consumption within the building or buildings on the premises."

Section 3. That this Ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by law.
