## AN ORDINANCE AMENDING SUB-SECTION 21.17 (G) 4. A. DECISIONS, OF CHAPTER 21, OF THE MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (as amended)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, find that it is in the best interest of the residents of the City that the current zoning code for the City of LeRoy be amended in respect to certain decisions to be made by the Zoning Board of Appeals,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. That Sub-section 21.17 (G) 4. A. Decisions, Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby repealed.

Section 2. That new Sub-section 21.17 (G) 4. A. Decisions, Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby adopted in words and figures as follows:

4. A. Decisions . The concurring vote of a majority of the members of the Zoning Board of Appeals present at a duly constituted meeting of the Zoning Board of Appeals of the City of LeRoy shall be necessary to recommend to the City Council and, when applicable, to decide a variation. Council, by ordinance and without further public hearing, may adopt a proposed variation, other than a variation upon which the Zoning Board of Appeals is required to decide, or that may be referred to the Zoning Board of Appeals for further consideration, and any such request for variation which fails to receive a favorable recommendation of the Zoning Board of Appeals shall not be adopted except by favorable vote of three-fourths (3/4) of all the corporate authorities of the City of LeRoy, Illinois, then holding office. All decisions made by the Zoning Board of Appeals shall be considered subject to review by the City Council upon the zoning relief applicant filing a letter petition with the City Clerk within thirty (30) days after the decision of the Zoning Board of Appeals has been communicated to the applicant. decision of the Zoning Board of Appeals not made the subject of a request for review to the City Council shall be deemed final at the conclusion of the aforesaid thirty (30) days. All decisions made by the City Council, whether upon review, or as a decision based on a recommendation or other matter that was first made a matter of hearing before the Zoning Board of Appeals, shall also be considered final. All final decisions, whether of the Zoning Board of Appeals or of the City Council, shall be subject to judicial review in accordance with applicable statutes of the State of Illinois. No order of the City Council, or, when applicable, the Zoning Board of Appeals, granting a variation shall be valid for a period longer than one year from the date of such order unless the building or any other required permit is obtained within such period and the erection or alteration of a building, structure or land improvement has been substantially completed or the use has commenced within such period.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
