ORDINANCE NO. 685

AN ORDINANCE AMENDING CHAPTER 21 ZONING OF THE MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS 1975 (AS AMENDED)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined it is in the best interests of the City and its residents that a certain amendment be made to the Zoning Code of the City of LeRoy; and

WHEREAS, one or more hearings have been held by the Zoning Board of Appeals of the City of LeRoy to consider the proposed text amendment as set forth hereinafter, due notice having been given for any and all said hearings,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. Chapter 21 Zoning, Municipal Code of the City of LeRoy, Illinois 1975 (as amended), Section 21.18 (g) 3. Procedure, is hereby amended by substitution of the dollar amount "\$50.00" in place of the blank space, as provided in the last sentence of said sub-section, which blank space was made in amendment to the aforesaid section 21.18 (g) 3. Procedure., by Ordinance No. 667, adopted by the City Council of the City of LeRoy, on May 20, 1996. By omission, the blank space was not filled in at the time the ordinance was approved. This ordinance is intended to make the amendment in order to complete said section to provide a fee of \$50.00 in place of the earlier fee provided, which was \$30.00.

Section 2. All ordinances, or parts thereof, and resolutions, or parts thereof, in conflict with this ordinance shall be and the same are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.




