ORDINANCE NO. 61

An ordinance annexing certain territory to the City of LeRoy, McLean County, Illinois;

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF LE ROY, ILLINOIS:
