

ORDINANCE NO. 127

AN ORDINANCE APPROVING THE ANNEXATION FILED HEREIN

WHEREAS, there was heretofore filed with the City Clerk of the City of LeRoy, McLean County, Illinois, an annexation agreeing to annex land described in Exhibit A, which is attached hereto and by this reference made a part hereof; and

WHEREAS, the owners have complied with the requirements of the City of LeRoy, McLean County, Illinois, City Code.

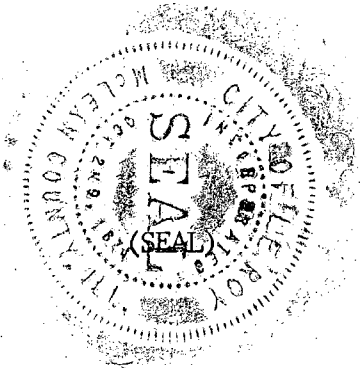
