ORDINANCE 137

Be it ordained by the City Council of the City of LeRoy, Illinois as follows:

WHEREAS the City Council of the City of LeRoy, Illinois has received a petition from the owners to vacate a portion of White Street in LeRoy, Illinois, and

WHEREAS the City Council finds that there will be no inconvenience to the public if said street and the alley located in Block 37 are vacated, and

WHEREAS there is a sewer line serving the residents of the City of LeRoy located in said street right-of-way,

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

1. That portion of White Street lying between Blocks 37 and 38 in Conkling's Addition to the City of LeRoy lying North of the right of way of the New York Central Railroad all in McLean County, Illinois is hereby vacated; provided, however, that this vacation shall not affect in any way the rights of the public and the City of LeRoy in and to the sewer line lying in said right-of-way and the City of LeRoy shall continue to have the right to maintain, repair or replace said sewer line as it may require;

2. The alley located in Block 37 of Conkling's Addition, running in an East West direction ~~and lying between Lots 3, 4, 5 and 6 on the North and Lots 7, 8, 9 and 10 on the South~~ is hereby vacated; *Jed.*

3. The City Council of the City of LeRoy further finds that that portion of White Street lying South of the New York Central Right-of-Way between Blocks 37 and 38 of Conkling's Addition of


the City of LeRoy should also be and is hereby vacated; provided, however, that this vacation shall not affect in any way any easements for public utilities which may exist in said street right-of-way;

4. Notwithstanding any other provision of this ordinance vacating portions of White Street in LeRoy, Illinois, the City of LeRoy does hereby reserve to itself an easement for public utilities described as follows: The East 10 feet of the West 20 feet of that portion of the right-of-way of White Street which is vacated by this ordinance; this reservation of an easement is for the purpose of allowing the City of LeRoy to install, maintain and operate public utilities within said easement. Further, the City of LeRoy may grant the power to other public utilities to construct underground lines in said easement. Provided, however, that neither the City of LeRoy nor any other public utility shall have the right to maintain poles or wires above the ground within said easement. Further, if either the City of LeRoy or any other public utility shall desire to lay utility lines in the easement described above, the City of LeRoy or the public utility doing said installation shall, after the installation of such lines, restore the premises to their former state as nearly as may be. Further, the City of LeRoy reserves an easement for the purposes of construction which shall encompass the easement above described and an additional ~~TEN~~^{TEN} feet on either side of said easement for construction purposes only.
