ORDINANCE NO. 187

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF LeROY, McLEAN COUNTY, ILLINOIS (TERRITORY TO BE ANNEXED COMMONLY KNOWN AS - CITY OF LeROY LANDFILL).

Whereas, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois Municipal Corporation, have determined that it will be in the best interests of the city and its residents to annex that territory contiguous to the city and known as the City of LeRoy Landfill into the city limits, and

Whereas, the City of LeRoy owns certain property contiguous to and south of the present municipal limits, said property commonly known as the City of LeRoy Landfill, and

Whereas, Chapter 24, paragraph 7-1-9, Illinois Revised Statutes, 1981 (as amended), provides that any territory contiguous to a municipality, uninhabited, unincorporated and owned by that municipality, may be annexed by that municipality by passage of an ordinance to that effect describing the territory to be annexed,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled:

Section 1. That the land commonly known as the City of LeRoy Landfill and contiguous to the City of LeRoy, described as follows:

All of the West one-half of the Southeast Quarter of the Northeast Quarter of Section 32, and a strip of land lying West of the above in said Section 32, beginning at the Southwest Corner of the same being 1.03 chains wide East and West and 27.30 chains North and South, all in Town 22 North, Range 4 East of the Third P.M., lying North of the Highway comprising 20 acres more or less,

is hereby annexed to the City of LeRoy, McLean County, Illinois.

Section 2. That the city clerk is hereby directed to record with the Recorder of Deeds of McLean County, and to file with the County Clerk of McLean County, a certified copy of this ordinance, together with the accurate map of this territory annexed appended to said ordinance.

Section 3. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

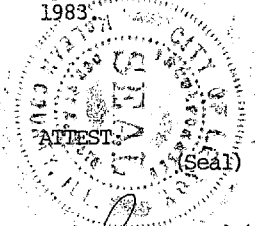

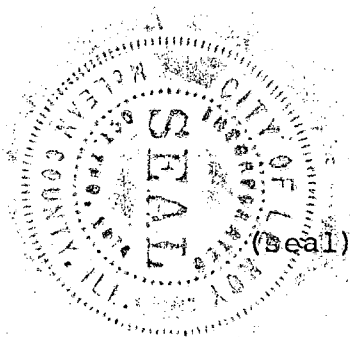

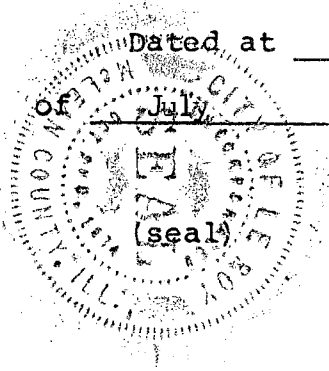
I further certify that on July 18, 1983, the Corporate Authorities of such municipality passed and approved Ordinance No. 187, entitled:

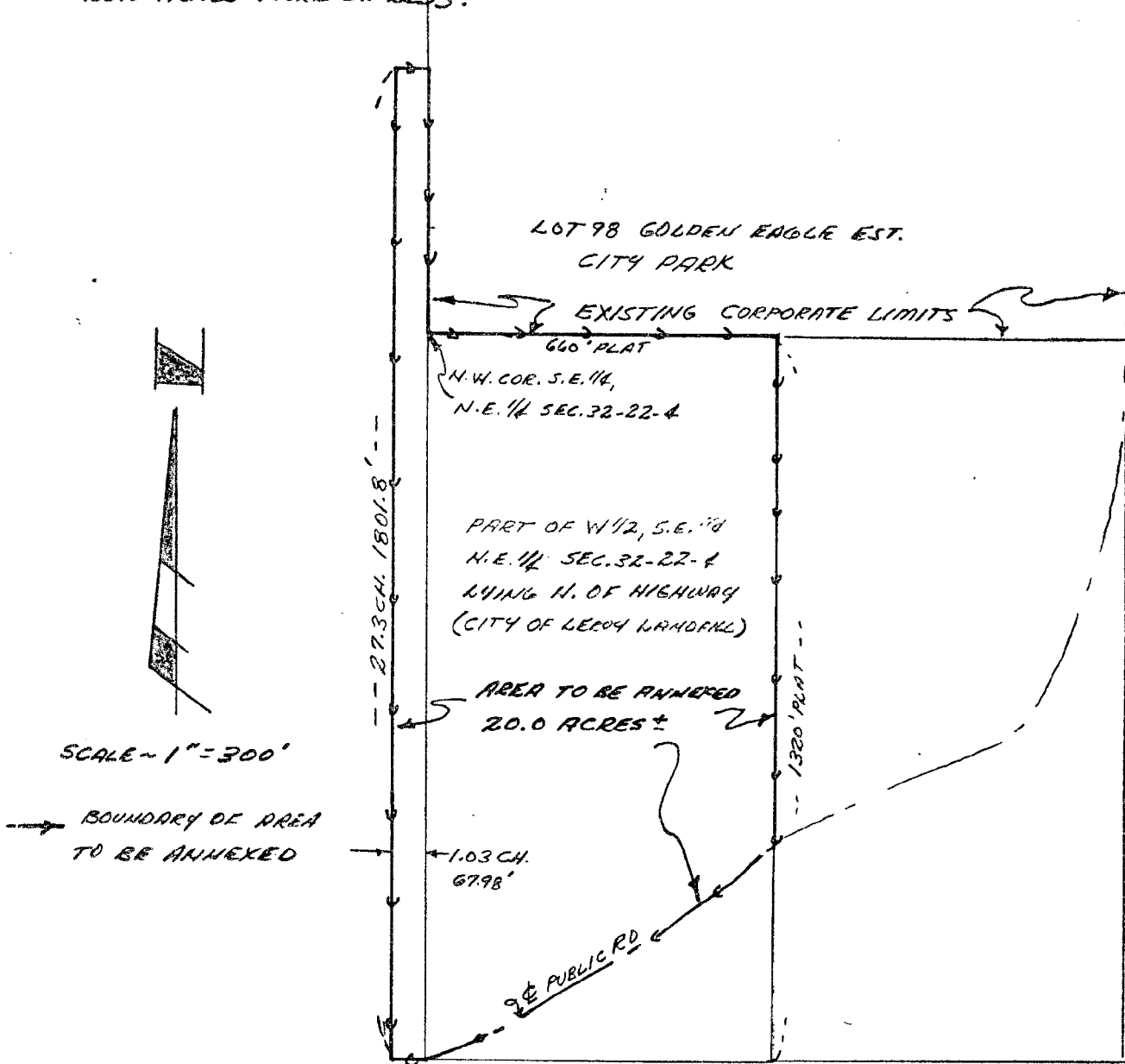



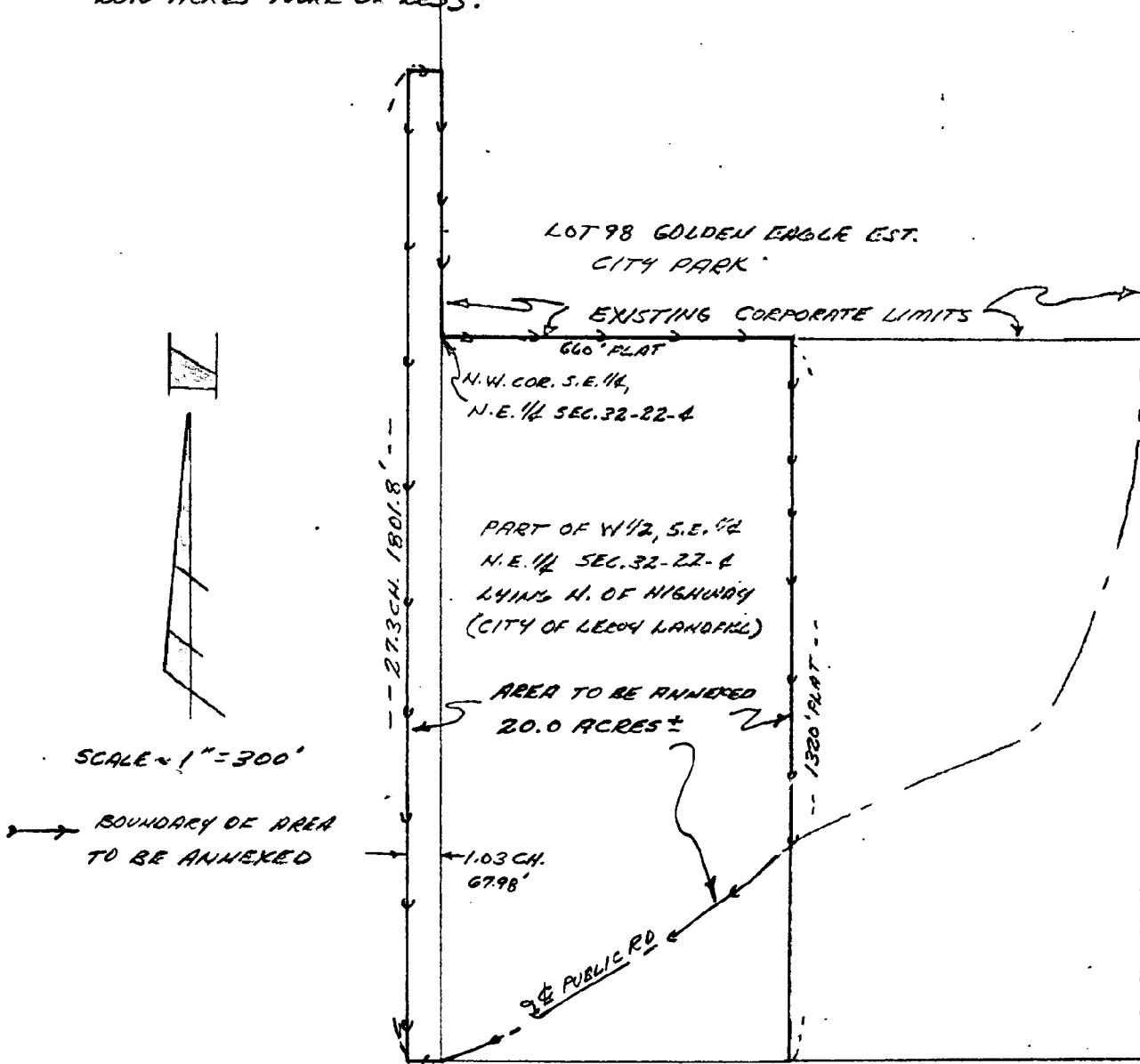
