AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF LE ROY, MC LEAN COUNTY, ILLINOIS (TERRITORY TO BE ANNEXED COMMONLY KNOWN AS LOT 17, BUCKLES GROVE SUBDIVISION, MC LEAN COUNTY, ILLINOIS)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it will be in the best interests of the city and its residents to annex the territory contiguous to the city and known as Lot 17 in Buckles Grove Subdivision, and more particularly described hereinafter; and

WHEREAS, Steven J. Sturm and Marilyn J. Sturm own certain property contiguous to and north of a portion of the present municipal limits bounding the north side of Golden Eagle Estates Subdivision of the City of LeRoy, McLean County, Illinois, said property contiguous to the Golden Eagle Estates Subdivision being commonly known as Lot 17 in Buckles Grove Subdivision; and

WHEREAS, Chapter 24, Paragraph 7-1-8, Illinois Revised Statutes 1989 (as amended), provides that any territory contiguous to a municipality, which is uninhabited and as to which all owners of record of all said territory file a written petition with the municipal clerk requesting annexation of same, may be annexed by that municipality by passage of an ordinance to that effect describing the territory to be annexed:

required by law, and that proof of the service of said notice is set forth in Group Exhibit "B" by affidavit of service.

Section 4. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
