### ORDINANCE NO. 780

## AN ORDINANCE AMENDING THE MUNICIPAL CODE OF THE CITY OF LE ROY, ILLINOIS, 1975 (as amended), CHAPTER 21, ZONING-MAP AMENDMENT

WHEREAS, a petition for change of zoning district (from time to time hereinafter referred to as "rezoning") was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking to rezone said premises from a zoning classification of R-2, General Residential, to C-2, Highway Commercial; and

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois, on January 8, 1998, at 7:04 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of Le Roy, McLean County, Illinois to consider said petition, after due notice was given in accordance with all applicable laws and ordinances; and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of City of Le Roy, Illinois, that said petition to rezone the property described hereinafter be approved; and

WHEREAS, all things required by law and ordinance to be done in regard to the rezoning of the hereinafter described property have been completed; and

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois an Illinois municipal corporation, find such rezoning request to be in the best interests of the city and its residents,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois is lawful meeting assembled, as follows:

Lot 3 in the Re-survey of Lots 3 through 8 in the SW ¼ of Section 21, Township22 North, Range 4 East of the Third Principal Meridian in the County of McLean, Illinois.

Is hereby rezoned as C-2, Highway Commercial District, and said zoning classification shall be applicable effective the date of this ordinance. The City Clerk and City Engineer are hereby directed to take all action as may be necessary to amend the official zoning map of the City of Le Roy in accordance with this ordinance.

<u>Section 2.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
