## AN ORDINANCE REZONING CERTAIN PROPERTY FROM THE L-1 LIGHT INDUSTRIAL ZONING DISTRICT TO THE R-1 ONE & TWO FAMILY RESIDENTIAL ZONING DISTRICT

- WHEREAS, the City of Le Roy is an Illinois non-home rule municipality organized and operating under the Illinois Municipal Code; and
- WHEREAS, the City desires to amend the City's zoning map to rezone certain property described in Section 2 of this Ordinance ("Property") from the L-1 Light Industrial District to the R-1 One & Two Family Residential District; and
- WHEREAS, in accordance with Section 10-2-7 of the City Code of the City of Le Roy and pursuant to notice duly published, the Le Roy Zoning Board of Appeals conducted a public hearing on November 12, 2015, for the purpose of hearing and considering testimony on the proposed rezoning; and
- WHEREAS, at the conclusion of the public hearing, the Zoning Board of Appeals recommended approval of the proposed rezoning of the Property; and
- WHEREAS, the Mayor and City Council of the City of Le Roy find and determine that it is in the best interests of the City that the Property be rezoned from the L-1 Light Industrial District to the R-1 Residential District.
- **NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Le Roy, McLean County, Illinois, as follows:
- **Section 1.** Recitals. The Council hereby finds that all of the recitals contained in the preambles to this Ordinance are full, true and correct and does incorporate them into this Ordinance by this reference.
  - Section 2. <u>Description of the Property</u>. The Property is described as follows:
  - Conklings Addition to the City of Le Roy lots 2 and E ½ Lot 3 and N ½ VAC Alley within Block 39 and identified as PIN No. 30-20-434-010 and commonly referred to as 103 South Buck Street, Le Roy, IL.
- **Section 3.** Zoning Map Amendment. The City Council hereby approves an amendment to the zoning map to rezone the Property described in Section 2 of this Ordinance from the L-1Light Industrial Zoning District to the R-1 One and Two Family Residential Zoning District.
- **Section 4.** Conflict. All Ordinances and parts of Ordinances in conflict with this Ordinance are hereby repealed.
- **Section 5.** Effective Date. This Ordinance shall be in full force and effect following its passage and approval as required by law.
