**AN ORDINANCE AMENDING CHAPTER 2, CITY COUNCIL,
SECTION 2.02 COUNCIL MEETINGS, OF THE MUNICIPAL CODE OF THE
CITY OF LEROY, ILLINOIS, 1975 (AS AMENDED)**

WHEREAS, the Mayor and City Council of the City of LeRoy have determined it is in the best interests of the City of LeRoy and its citizens to change the time to begin regular City Council meetings,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. Chapter 2, City Council, Section 2.02 Council Meetings, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), is hereby amended by changing the hour designated in the third line of said ordinance for the commencement of regular meetings of the City Council from the hour of 7:30 p.m. to the hour of 7:00 p.m.

Section 2. Regular City Council meetings shall continue to be held on the first and third Mondays of each month of the year as set forth in the aforesaid section 2.02, with regular meetings falling upon a legal holiday being held on the next following secular day at the same hour and place, as set forth in the aforesaid section. In all other respects the aforesaid section 2.02 shall continue in full force and effect as amended by this ordinance.

Section 3. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
