ORDINANCE NO. 190

WHEREAS, A petition to rezone the following described real estate:

West 1/2 of Lot 4 and all of Lots 5, 6 and 7, Block 49
Conklings Addition

seeks to rezone said premises from a Classification of R-1, 1 & 2 Family Residential to R-2, General Residential, and

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois on Thursday, September 29, 1983 at 7 P.M. in the City Hall, in accordance with law to consider said Petition, and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of the City of Le Roy, Illinois approval of said Petition for change of zoning classification of the above described premises, and

WHEREAS, all things required by law to be done in and about the rezoning of said property have been completed:

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled, as follows:

The West 1/2 of Lot 4 and all of Lots 5, 6 and 7, Block 49,
Conklings Addition

are hereby zoned R-2, General Residential.

This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by city ordinance and state law.
