ORDINANCE NO. 267

AN ORDINANCE AMENDING THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975, CHAPTER 21, ZONING - MAP AMENDMENT.

WHEREAS, a petition to rezone the following described real estate:

Lots 6 through 13 inclusive, all in Central Prairie's Commercial Park, a re-subdivision of Lots 3, 5, 6 and 7 of Buckles Grove Bicentennial Addition in the East 1/2 of Section 29, Township 22 North, Range 4 East of the Third Principal Meridian, as shown on the plat recorded July 18, 1980, as Document No. 80-6996, recorded in the Office of the Recorder of Deeds of McLean County, Illinois, said Central Prairie's Commercial Park being an addition to the City of LeRoy, McLean County, Illinois,

seeks to rezone said premises from a zoning classification of R-1, one and two Family Residential, to R-2, General Residential, and

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of LeRoy, Illinois, on December 5, 1985, at 7 p.m., at the City Hall, LeRoy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of LeRoy, McLean County, Illinois, to consider said petition, and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of the City of LeRoy, Illinois, that said petition for change of zoning classification as to the above described premises be approved, and

WHEREAS, all things required by law to be done in and about the rezoning of said property have been completed;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. That the previously described property, being Lots 6 through 13 of the Central Prairie's Commercial Park Addition to the City of LeRoy, McLean County, Illinois, is hereby zoned R-2, General Residential.

Section 2. That this Ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by law.
