**AN ORDINANCE APPROVING A SPECIAL PERMITTED USE OF THE  
MUNICIPAL CODE, LE ROY, ILLINOIS, 2007  
TITLE 10, ZONING**

**WHEREAS**, a petition to permit a special permitted use for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a special permitted use to allow for an apartment over a warehouse in an industrial zoned area,

**WHEREAS**, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois, on January 4, 2007 at 7:00 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the Ordinance of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances, and

**WHEREAS**, said Zoning Board of Appeals did hold a hearing as required by the laws of the State of Illinois and the Ordinance of the City of Le Roy, McLean County, Illinois and did recommend that said petition for special permitted use to allow an apartment over a warehouse, and

**WHEREAS**, all things required by law and ordinance to be done in regard to the variation of the hereinafter described property have been completed,

**NOW, THEREFORE BE IT ORDAINED**, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

**SECTION 1.** As to the real estate described as follows:

Half of lot 8 and all of lot9 in Block 45 of the original Town of LeRoy, McLean County, Illinois.

**(308 W. Cherry)**

is hereby granted a special permitted use to allow for an apartment above a warehouse.

**SECTION 2.** This ordinance shall be in full force and effect from and after its passage and approval as required by law.






