AN ORDINANCE APPROVING AN ADDITIONAL PERMITTED USE IN THE I-1, LIGHT INDUSTRIAL, ZONING DISTRICT OF THE CITY OF LE ROY, ILLINOIS

WHEREAS, a petition to allow an auction house as an additional permitted use in the I-1, Light Industrial, zoning district in the City of LeRoy, at the site described hereinafter, has been received by the City of LeRoy, and acted upon as required by law by the zoning board of appeals; and

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of LeRoy, Illinois, on May 21, 1992, at 7:00 p.m., at the City Hall, LeRoy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of LeRoy, McLean County, Illinois, to consider said petition, and

WHEREAS, said zoning board of appeals has made findings to the effect that an additional permitted use for an auction house at that location described hereinafter would be compatible with the other light industrial uses permitted in the district, and that said zoning board of appeals has recommended to the City Council of the City of LeRoy, Illinois, the approval of the additional permitted use request, and

WHEREAS, all things required by law and ordinance to be done regarding the granting of the aforesaid additional permitted use request have been completed,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

SECTION 1. As to the real estate described as follows:

Parcel No. 1: Lots 3,4,5,6,7,8,9 and 22 feet off the West Side of Lot 10 in Block 39 in Conkling's Addition to the Town of LeRoy, in McLean County, Illinois.

Parcel No. 2: The North 1/2 of the vacated alley lying South of Lots 3, 4, 5 and 6 and the South 1/2 of the vacated alley lying North of Lots 7,8,9 and the West 22 feet of Lot 10, all in Block 39 in Conkling's Addition to the Town of LeRoy, in McLean County, Illinois,

(the aforesaid parcels also being commonly known as 507 West Pine, LeRoy, Illinois),

use as an auction house as an additional permitted use in the I-1, Light Industrial, zoning district of the City of LeRoy is hereby permitted.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
