# AN ORDINANCE APPROVING A VARIATION OF SIGN REGULATION SET-BACK REQUIREMENTS OF THE MUNICIPAL CODE OF THE CITY OF LE ROY, ILLINOIS, 1975(as amended) CHAPTER 21, ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a variance in sign regulation set-back requirements in the C-2, Highway Commercial District, said variance request:

A variation in sign requirement setback for a free standing business or advertising sign to be erected (3) feet from the street right of way, thus the variance requested being the variance from the fifteen (15) foot set-back requirement to a three (3) foot set-back requirement.

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois, on June 12, 2003 at 7:00 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the Ordinance of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances, and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of the City of Le Roy, Illinois, that said petition for variation in sign regulation setback requirements of 15 foot in the C-2, Highway Commercial District, to a 3 foot setback to allow for the construction of a free standing sign.

WHEREAS, all things required by law and ordinance to be done in regard to the variation of the hereinafter described property have been completed,

**NOW, THEREFORE BE IT ORDAINED,** by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

**SECTION 1.** As to the real estate described as follows:

Lots 1, 2, 3, & 4, Block 58, Conklings Addition City of Le Roy, McLean County, Illinois (502 West Washington St.)

requiring a 15 foot setback of a sign along the front property line is hereby granted a variation from the required sign setback of 15 foot to a setback of 3 foot to allow for the construction of a free standing sign.

**SECTION 2.** This ordinance shall be in full force and effect from and after its passage and approval as required by law.
