AN ORDINANCE APPROVING A VARIATION IN REAR YARD SETBACKS OF THE MUNICIPAL CODE, LE ROY, ILLINOIS, 2003 TITLE 10 ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a variance in the setback requirement for an accessory building of 5 feet from the rear lot line to allow a detached garage to be placed 2.5 feet from the lot line.

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois, on July 14, 2005 at 7:00 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the Ordinance of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances, and
