

**ORDINANCE NO. 07-02-01-10**

**AN ORDINANCE APPROVING A VARIATION IN FRONT YARD SETBACKS  
OF THE MUNICIPAL CODE, LE ROY, ILLINOIS, 2003  
TITLE 10, ZONING**

**WHEREAS**, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a variance in the front yard setback of 27 feet to allow parking spaces to be 15 and 20 feet from the property line in C-2 district..

**WHEREAS**, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois, on February 15, 2007 at 7:00 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the Ordinance of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances, and

**WHEREAS**, said Zoning Board of Appeals did hold a hearing as required by the laws of the State of Illinois and the Ordinance of the City of Le Roy, McLean County, Illinois and did recommend that said petition for variation in the front yard setback of 27 feet to allow parking spaces to be 15 feet on the south side, and 20 feet on the east side from the property line., and

**WHEREAS**, all things required by law and ordinance to be done in regard to the variation of the hereinafter described property have been completed,

**NOW, THEREFORE BE IT ORDAINED**, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

**SECTION 1.** As to the real estate described as follows:

Lot 1 in the LeRoy Plaza Subdivision

Requiring a minimum setback of 27 ft. is hereby granted a variation from the required minimum setback to allow for parking 15' along Sunset Dr. and 20' along East St. from the frontyard lot lines.

**SECTION 2.** This ordinance shall be in full force and effect from and after its passage and approval as required by law.

day of February, 2007, as follows:






