ORDINANCE NO. 07-04-03-10

AN ORDINANCE AMENDING TITLE 3; CHAPTER 5 OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS, 2003, BUSINESS AND LICENSE REGULATIONS

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have reviewed the fees for Business and License Regulations; and

WHEREAS, the Mayor and City Council of the City of Le Roy have determined that said fees shall be repealing, being in the best interest of the city and its residents; and

WHEREAS, all things required by law an ordinance to be done in regard to repealing said fees has been completed;

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

- **SECTION 1.** Title 3, Business License Regulations, Chapter 5, Section 3A &B of the Municipal Code of Le Roy, Illinois 2003, is hereby amended by repealing Chapter 5 Section 3:
- A. Amusement Establishments: All fees for business licenses required by reason of the regulations contained in subsection 3-5-2A of this chapter shall be paid in advance at the time application therefor is made to the city clerk in the amount prescribed by the city. (2003 Code)
- B. Amusement Devices: License fees for skill or entertainment devices shall be two hundred dollars (\$200.00) per year for one or more machines, said fee to be paid for the privilege of having one or more such machines at any location. Such fee shall be due per building, room or public place in the city, it being the intention of the city that at one location under the name of one owner of the business at that location that should the owner have any such skill or entertainment machines at said location, the fee due annually for the license for such skill or entertainment devices at that location under the same ownership shall be two hundred dollars (\$200.00) per year. SECTION 2. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
