ORDINANCE NO. 517

AN ORDINANCE AMENDING LICENSE FEES FOR AMUSEMENT DEVICES, AND AMENDING CHAPTER 32. SECTION 32.05 - AMUSEMENT DEVICES

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City of LeRoy and it residents that a maximum limit be placed on license fees required to paid annually for skill or other entertainment devices, the same being also referred to as "amusement devices,"

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

Section 1. Ordinance No. 468 and Section 32.05 - Amusement Devices (b), of Chapter 32, Business Regulations, of the Municipal Code of LeRoy, Illinois, 1975 (as amended), are hereby amended by deletion and repeal of the aforesaid subsection (b) in their entirety.

Section 2. Section 32.05 - Amusement Devices, of Chapter 32, Business Regulation, of the Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby amended by addition of new subsection (b) in those words and figures as follows:

License fees shall be \$20.00 per year for each music machine, and \$50.00 per year for each skill or other entertainment device. License fees for skill of other entertainment devices (\$50.00 per year per device) shall not exceed a maximum of \$100.00 per year for two (2) to four (4) machines, and shall not exceed \$175.00 per year for five (5) or more machines, said maximums being intended per building, room or public place in the city, it being the intention of the city that at one location under the name of one owner of the business at that location that should the owner have more than five machines at said location, the maximum fee due annually for the license for all skill and entertainment devices at that location under the same ownership shall not exceed \$175.00.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
