## ORDINANCE NO. 676

AN ORDINANCE GRANTING A VARIANCE TO THE CITY ZONING CODE, CHAPTER 21, MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS 1975 (as amended)

WHEREAS, the Zoning Board of Appeals of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, held a hearing on May 6, 1996, at 7:30 p.m., at the City Hall, City of LeRoy, Illinois, regarding a petition by James and Kimberly Lutes requesting a variance as to the West 44 feet of Lot 7 in Block 16 in the Original Town of LeRoy, McLean County, Illinois, commonly known as 212-214 E. Center Street, LeRoy, Illinois, said application being for variance to permit a temporary dwelling on the first floor of a two-story building located in the C-1, Central Commercial District of the City of LeRoy; and

WHEREAS, the Mayor and City Council of the City LeRoy have reviewed and considered the report of the Zoning Board of Appeals regarding the aforesaid hearing, have reviewed the findings of fact and reasons suggested both in favor of granting the variance and against granting the variance, said reasons having been formulated by the aforesaid Zoning Board of Appeals, and have considered the recommendation of said Zoning Board of Appeals to grant the variance; and

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, have determined that the applicants intend to and are capable of remodeling and refurbishing the property located at 212-214 E. Center Street, LeRoy, Illinois, sometimes referred to as the "LeRoy Opera House", considered to be one of the historic buildings in the City of LeRoy, and in the Central Commercial District of the City of LeRoy,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. The LeRoy City Council finds that the LeRoy Opera House is an historic structure, is located in the LeRoy historic business district, that the building has not been occupied

for several years on a regular basis, that no regular business establishment has been located in the building for several years, that the building is in a deteriorated condition and is continuing to deteriorate from lack of maintenance and care, and that it is in the best interests of the City and its residents to have the building maintained in better condition, and containing one or more regular business occupants, as well as being put to some use in keeping with its historic nature.

Section 2. A variance of Section 21.12 (b) 11. of the Municipal Code of the City of LeRoy, Illinois 1975 (as amended), is hereby granted to James Lutes and Kimberly Lutes for so long as they own the real estate located at 212-214 E. Center Street, LeRoy, Illinois, and legally described as the West 44 feet of Lot 7, in Block 16 in the Original Town of LeRoy, McLean County, Illinois, or for a period of twelve months beginning the date the applicants are granted possession of the premises, whichever period shall first expire. The date the applicants are granted possession of the subject premises is to be promptly documented, in writing, to the City Clerk of the City of LeRoy and to the Building and Zoning official of the City of LeRoy. Further, at such time as James and Kimberly Lutes give up use of the first floor of the aforesaid premises for dwelling purposes, this variance shall be terminated if not already terminated by occurrence of one of the other two events previously stated in this section.

Section 3. All of this ordinance, or parts thereof, resolutions, or parts thereof, in conflict with this ordinance shall be and the same are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.

Section 4. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section 3 of this ordinance; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.

Section 5. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
