**ORDINANCE NO. 07-02-02-10**

**AN ORDINANCE AMENDING TITLE 3; CHAPTER 3 OF  
THE MUNICIPAL CODE OF LE ROY, ILLINOIS, 2003**

**WHEREAS**, City Council of the City of Le Roy , McLean County, Illinois, an Illinois municipal corporation, hereinafter referred to as "City" has determined that it is necessary and in the best interests of the city and its residents that the Liquor License Application Fees be increased; and

**NOW, THEREFORE BE IT ORDAINED**, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

**SECTION 1.** That Title 3, Business and License Regulations, of the Municipal Code of Le Roy, Illinois 2003, Chapter 3, Liquor Control, Section 4, Application For License; Fee, (3-3-4) is hereby repealed.

**SECTION 2.** That Title 3, Business and License Regulations, of the Municipal code of Le Roy, Illinois 2003, Chapter 3, Liquor control, Section 4, Application For License; Fee: is amended as follows:

**3-3-4: APPLICATION FOR LICENSE; FEES:** Applications for licenses as required in accordance with this chapter shall be made in writing to the city local liquor control commissioner upon forms prepared and furnished by the city. Each application shall be signed and verified by the written oath or affirmation of the applicant, if an individual. If the applicant is a partnership, all partners shall sign and verify the application. In the event the applicant is a corporation, limited liability company or a club, all officers or managers must sign and verify the application and indicate their official position thereon. The information recited in the application form must be verified as to each person signing the application. Such application shall be submitted and filed with the city clerk, together with a nonrefundable filing fee in the amount of one hundred seventy five dollars (\$175.00). The \$175.00 application fee includes the expense for the background investigation for one individual. When more than one background investigation is required, an additional fee of \$50.00 will be assessed for each investigation required. The application shall contain the following information and statements: (Ord. 156, 12-7-1981; amd. Ord. 845, 6-7-1999; 2003 Code; Ord. 04-05-02-10, 5-17-2004)

**SECTION 3.** This ordinance shall be in full force and effect from and after its passage and approval as required by law.






