AN ORDINANCE AUTHORIZING THE ISSUANCE OF TAX ANTICIPATION WARRANTS IN ANTICIPATION OF TAXES LEVIED FOR THE YEAR 1982 OF THE CITY OF LE ROY, MC LEAN COUNTY, ILLINOIS.

Whereas, the Mayor and City Council of the City of LeRoy have determined that it is in the best interests of the City to purchase a sewer cleaning machine and root cutting machine made available by Sewer Jet, Inc. of Illinois and Missouri; and

Whereas, the Mayor and City Council of the City of LeRoy have determined the purchase of such equipment available at the purchase price offered by the company to be in the best interests of the City of LeRoy and its residents,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

Section 1. That money be borrowed from time to time, as needed, to provide sufficient funds for the purchase of a sewer cleaning machine and root cutting machine described as follows:

Sewer cleaning machine - 1972 Peabody Myers Model 800 Vactor, Myers Sherman Company

Root cutting machine - Model J 1601 O'Brien 3/4",

and to meet and defray the necessary expenses of such purchase by the City of LeRoy against and in anticipation of the collection of the tax levy for the year 1982 for general corporate purposes, and for the collection and disposal of garbage, trash, refuse and ashes, said warrants to bear interest not to exceed the greater of nine percent (9%) per annum or seventy percent (70%) of the prime commercial rate in effect at the time the money is borrowed under the warrants, from their date until paid or until notice shall be given by publication in a newspaper or otherwise that the money for their payment is available and will be paid on presentation, such warrants to show upon their face that they are payable in the numerical order of their issue and solely from such taxes when collected, and shall be received by any collector of taxes in payment of the tax against which they are issued. warrants shall not be issued in excess of eighty-five percent (85%) of the total amount of the tax so levied, which said tax is hereby assigned and pledged to the payment of said warrants, and such taxes when collected shall be set apart and held for their payment.

Section 2. That said warrants shall be in substantially the following form:
