AN ORDINANCE PROVIDING FOR AND APPROVING THE SALE OF PERSONAL PROPERTY OF THE CITY OF LERGY.

Whereas, the City of LeRoy, being a city organized under the laws of the State of Illinois and having less than 500,000 population, owns personal property which in the opinion of three-fourths of the corporate authorities now holding office is no longer necessary or useful to, or for, the best interests of said city; and

Whereas, a majority of the corporate authorities now holding office at a regular meeting held at 7:30 P.M. on July 18, 1983, did make the aforesaid determination;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled:

Section 1. That the 1972 TWC 915 Fitchburg Chipper, brush chopper, be sold by the City of LeRoy, by notice published in the local newspapers advertising the sale of the property soliciting sealed bids to be received not later than 5:00 P.M., August 1, 1983, at the City Hall in LeRoy, Illinois, which will be opened at 7:45 P.M., at the regular city council meeting that night, and at which time anyone present who shall have submitted a sealed bid may verbally increase his bid; the city shall have the right to refuse any and all bids.

Section 2. That such sale shall be effective with the highest bid to be awarded the sale of the equipment. Terms: Cash upon notice of successful bid, cash payment to be made at the City Hall not later than 4:00 P.M., August 3, 1983.

Section 3. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
