AN ORDINANCE PROVIDING FOR AND APPROVING THE SALE OF PERSONAL PROPERTY OF THE CITY OF LEROY,

WHEREAS, the City of LeRoy, being a city organized under the laws of the State of Illinois and having less than 500,000 population, owns personal property which in the opinion of three-fourths of the corporate authorities now holding office is no longer necessary or useful to, or for, the best interests of said city; and

WHEREAS, a majority of the corporate authorities now holding office at a regular meeting held at 7:30 P.M. on March 2 1981 , did make 1981 , did make the aforesaid determination;

NOW THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois:

Section 1. That the \_\_\_\_1964 Dodge Dump Truck, Vehicle Identification \_, be sold by the City of LeRoy, by notice published in the local newspaper advertising the sale of the property soliciting sealed bids to be received not later than 9:00 A.M., Monday, March 16, 1981, at the City Hall in LeRoy, Illinois, which will be opened at the regular City Council meeting at 7:30 P.M., March 16, 1981.

Section 2. That such sale shall be effective with the highest bid to be awarded the sale of the vehicle. Terms: Cash upon notice of successful bid, cash payment to be made at the City Hall not later than 11:00 A.M., Wednesday, March 18, 1981.

Section 3. That this Ordinance shall be in full force and effect from and after its passage and approval, as required by law.
