AN ORDINANCE APPROVING THE ANNEXATION OF PROPERTY

- WHEREAS, the City of Le Roy, McLean County, State of Illinois, is an Illinois Municipal Corporation organized under the Constitution and Statutes of the State of Illinois; and
- WHEREAS, the City has purchased certain real property, which is legally described on Exhibit "A" hereto (the "Property"); and
- WHEREAS, the Property is not now within the corporate limits of the City, but is contiguous to the said corporate limits; and
- WHEREAS, annexing the Property into the corporate limits of the City will further the development of the Property; and
- WHEREAS, on June 18h, 2007, at 7:15p.m., a public hearing was held and all legal notices were given according to the Illinois Municipal Code; and
- WHEREAS, this annexation is necessary to the furtherance of the development and growth of the City, the public interest requires and it is in the interest of the City.
- **NOW THEREFORE, BE IT ORDAINED** by the Mayor and City Council that the Property be annexed into the City of Le Roy on this 18th day of June, 2007:
- Section 1: That the preambles hereto are true and correct and are incorporated herein by reference as if fully set forth at this point.
- Section 2: That the Property legally described on Exhibit "A" hereto shall be annexed into the corporate limits of the City of Le Roy.
- <u>Section 3:</u> That all other ordinances and other enactments of the City that conflict herewith are hereby expressly repealed to the extent of said conflict.
- <u>Section 4:</u> This Ordinance shall be effective upon its passage, signing and publication as required by law.
