#### ORDINANCE NO. 18-02-02-52

## AN ORDINANCE AMENDING THE ZONING CODE – GROUP HOMES

**WHEREAS,** the City of Le Roy has enacted a comprehensive Zoning Code incorporated as Title 10 of the Le Roy City Code; and

WHEREAS, the 1988 Fair Housing Act Amendment to the 1968 Civil Rights Act provides for reasonable accommodation for persons with developmental disabilities by units of local government;

WHEREAS, the United States of the Department of Justice and the United States Department of Housing and Urban Development have issued guidance on accommodation of persons with disabilities pursuant to the 1988 Federal Fair Housing Act; and

WHEREAS, guidance issued by the U. S. Department of Justice requires that local zoning codes provide for and accommodate group homes in residential zoning districts; and

WHEREAS, it is in the best interests of the health, safety and welfare of the citizens of the City of Le Roy to amend the City of Le Roy Zoning Code in order to provide a definition for group homes, a process for a Special Use Permit in the Single Family Residential Zoning District and to permit group homes in the R-2 Residential District, all as provided herein; and

WHEREAS, the City of Le Roy Planning Commission, after notice as required by law, held a public hearing on the proposed amendments to the City of Le Roy Zoning Code, and prepared a report recommending the amendments provided herein.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF LE ROY, McLEAN COUNTY, ILLINOIS, as follows:

**SECTION 1.** That the report and recommendation of the Le Roy Planning Commission be and the same is hereby received.

**SECTION 2.** That Section 10-1-3 of the Le Roy City Code be and the same is hereby amended by adding the following definitions:

Group Home: A dwelling to provide a socially dependent family environment for developmentally or mentally disabled patients as specified in the 1988 Fair Housing Act Amendment to the 1968 Civil Rights Act. For purposes of this Chapter, the definition

shall not include half-way houses, uses for the recovering chemically-dependent, prison work-release programs, or any use that does not house solely the developmentally disabled.

Group Home Large: A group home of seven (7) to twelve (12) residents, including live-in staff.

**Group Home Small:** A group home of four (4) or fewer residents, plus two (2) live-in staff members.

**SECTION 3.** That Section 10-6A-3 of the City of Le Roy City Code be and the same is hereby amended by adding Group Home Small as a listed Special Use, provided no Group Home shall be located within one thousand (1,000) feet of another Group Home.

SECTION 4. That Section 10-6B-2 of the City of Le Roy City Code be and the same is hereby amended by adding the following as permitted uses: Group Home Small and Group Home Large. No Group Home, Large or Small, shall be located within one thousand (1,000) feet of another Group Home, Large or Small.

SECTION 5. Severability. In the event any section, clause, provision or part of this Ordinance shall be found and determined to be invalid by a Court of competent jurisdiction, all valid parts that are severable from invalid parts shall remain in full force and effect.

SECTION 6. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict hereof, are hereby repealed, provided, however, that nothing herein contained shall affect any rights, action, or causes of action, which have accrued to the City of Le Roy, prior to the effective date of this Ordinance.

**SECTION 7. Publication.** The City Clerk be and she is hereby authorized and directed to publish this Ordinance in pamphlet form, as provided by law.

**SECTION 8.** Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
