FIRST AMENDMENT TO AL ANNUAL APPROPRIATION ORDINANCE NO. 300
FOR THE CITY OF LE ROY, ILLINOIS, 1987-1988

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of said City to assist LeRoy Emergency Ambulance Service, Inc., an Illinois not-for-profit corporation, in defraying the expenses for electricity, natural gas, and other similar expenses from time to time incurred in the general operation and maintenance of the building utilized by said ambulance service and a portion of which is utilized for the LeRoy Police Department office and motor vehicle garage; and

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, may, in accordance with the laws of the State of Illinois, (C. 24, Para. 8-2-9, Illinois Revised Statutes, 1985 (as amended)), after the first half of the fiscal year, by 2/3 vote of all of the members of such body, make transfers within any department or other separate agency of the municipal government of sums of money appropriated for one corporate object or purpose so long as no appropriation for any object or purpose shall thereby be reduced below an amount sufficient to cover all obligations incurred or to be incurred against such appropriation,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled as follows:

Section 1. That Appropriation Ordinance No. 300, being the general appropriation ordinance for the City of LeRoy for fiscal year 1987-1988, is hereby amended by the addition of the following words and figures as a separate line item at the end of all other line items set forth in III. B.:

"For expense of maintaining Police Department office and garage space, including electricity, heat, water, and in addition thereto including dispatching services.......\$2,500.00

To the extent of said appropriation, the sub-totals and totals of the appropriation of III. B., Police Department, Are considered amended consistent with the addition of the line item for \$2,500.00.

Section 2. That the line item under III. C., Capital Items, for the sinking fund for the replacement of the second squad car, is hereby reduced from \$7,000.00 to \$4,500.00, and to the extent of said change in the appropriations for the police department, the subtotal of the appropriation from \$7,000.00.

Section 3. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
