#### ORDINANCE NO. 592

# FIRST SUPPLEMENTAL ANNUAL APPROPRIATION ORDINANCE FOR THE CITY OF LEROY, ILLINOIS, 1994-95

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the residents and of the City of LeRoy to demolish that structure known as the HOW Building, located at 213-217 East Center Street, LeRoy, Illinois, as it represents a hazard to the public health, safety and welfare; and

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, have determined that revenues will be available to the City of LeRoy in addition to those initially anticipated and appropriated when the annual appropriation ordinance for the City of LeRoy for the fiscal year 1994-1995 was adopted,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

Section 1. That Appropriation Ordinance No. 553, being the general appropriation ordinance for the City of LeRoy for fiscal year 1994-1995, is hereby amended by the addition of the following words and figures as a separate line item at the end of all other line items set forth in I.B.:

"For expense of demolition of that structure known as the HOW Building, located at 213-217 East Center Street, LeRoy, Illinois, disposal of debris from the demolition, and clean-up of the site, and for expense of issuing bonds in connection with such project......\$88,000.00"

To the extent of said additional appropriation, the sub-totals and totals of the appropriation for the General Administration Department, and of the total appropriation ordinance of the City, are considered amended consistent with the addition of the line item for \$88,000.00.

- <u>Section 2</u>. The new revenues to the City expected to be received are the result of the sale of a general obligation bond under authority of 65 ILCS 5/8-5-16 which revenues are expected to amount to \$88,000.00 or more.
- <u>Section 3</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
