**ORDINANCE NO. 19-08-03-90**

**AN ORDINANCE PURSUANT TO TITLE SIX, CHAPTER THREE, SECTION THREE OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS, 2006, PARKING SPACES FOR HANDICAPPED PERSONS**

**WHEREAS**, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, hereinafter referred to as "CITY", have determined that it is necessary and beneficial for the citizens of the City of Le Roy that handicapped parking spaces be designated in the CITY, and

**WHEREAS**, Illinois state statutes provide for the regulation and enforcement of handicapped parking spaces; and

**WHEREAS**, the Mayor and City Council of the City of Le Roy has previously adopted an ordinance providing for the designation of handicapped parking spaces; and

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council of the City of Le Roy, in lawful meeting assembled on Monday, August 19, 2019, as follows:

That Title 6, Chapter 3, Section 3, Subsection C 1, Municipal Code of the City of Le Roy, Illinois, 2003, is hereby amended by adding the following language in **bold**:

Public parking spaces for handicapped persons shall be designated by city ordinance. Effective the date of this ordinance, handicapped parking spaces are hereby designated as follows:

1. One (1) space in front of the Town Hall Building, 111 East Center Street, the same being the first space nearest the front of the building on the east end of the available parking spaces located on the south side of Kiwanis Park and Center Street in block 18; and
2. One (1) space in the Le Roy municipal building parking lot, 207 S East Street, being the first space on the south side of the drive near the East Street entrance to the property; and
3. One (1) space being the furthest north space on the east side of South Chestnut Street at the intersection of Chestnut Street and East Center Street, on the southeast quadrant of the intersection; and
4. One (1) space being the furthest space east on the north side of East Center Street in the block of said street located between North Chestnut and North East Street, at the north west quadrant of the intersection; and

5. One (1) space being the first parking space in the 100 block of North Main Street on the east side, immediately north of the intersection of Center and Main, on the east side of North Main in the first block north of Kiwanis Park; and
6. One (1) space in front of the Spiritualist Church at 102 South Pearl Street, the north most boundary line of said space being 52 feet south of the south right-of-way line of East Center Street, measured from the intersection of the south right-of-way line of East Center Street and the east right-of-way line of South Pearl Street; and
7. One (1) space being the furthest parking space to the north of Kiwanis Park in the 100 block of East Center Street in the parking area northeast of Kiwanis Park, between the intersection of East Center Street and North Main Street; and
8. One (1) space being the furthest west space on the south side of East Center Street at the intersection of Chestnut and Center Streets, on the southeast quadrant of the intersection; and
9. One (1) space being the last parking space in **the 100 block** of West Center Street on the west side, immediately north of the intersection of Center and Main, on the west side of North Main in the first block north of Kiwanis Park.
10. One (1) space being the closest parking space north of the alley located between Center Street and Pine Street in the 100 block of South Chestnut Street on the west side of South Chestnut Street.
- 11. One (1) space on the south side of Bowman Park at 406 E Center St between Pearl Street and Mill Street on the north side of East Center Street.**

This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.

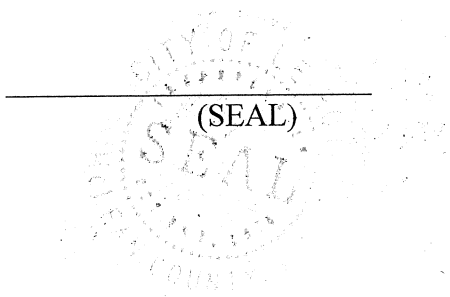
